Students seeking a modified school day must meet at least one of the following requirements. Students must be in good academic standing and on track to graduate with their cohort and have parents/guardians permission along with the permission of the administration.

1. Be enrolled in an approved Technical Education Training Program.
2. Enrollment in an approved Dual Enrollment course during the hours of 8:00 a.m. until 4:00 p.m. and taken on the campus of the college providing the course or taken on the campus of Deshler High School.
3. Enrolled in Deshler High School.
 - a. Eligibility requirements are as follows:
 - i. Be a senior in good academic standing, on track to graduate, must be at least 17 years of age, and credentialed in at least one area.
 - ii. Be a junior in good standing enrolled in Work Based Learning or a college course.
 - iii. Be gainfully employed, seeking employment, or enrolled in dual enrollment.
 - iv. Be enrolled in at least two (2) courses on the campus of Deshler High School.
 - v. Approved by the senior counselor along with transcript and records checks.
 - vi. Students must sign out/in daily through the Attendance Office on the campus of Deshler High School with the exception of Work Based Learning.
 - b. Failure to maintain good academic standing will result in the student forfeiting the right to be involved in the modified school day.
 - c. Failure to maintain good behavior during school will result in the student forfeiting the right to be involved in the modified school day.

d. It is the responsibility of the student and parents/guardians to retrieve all information distributed during the day regarding to senior activities other than the normal promulgation of announcements.

e. Students may be allowed to participate in extra-curricular activities as a normal student would be allowed provided they maintain good academic and behavior standing with the school.

f. Final approval or rejection rests with the administration of Deshler High School.
