Parent/Guardian and Student Electronic Device Usage Agreement

All guidelines listed below must be followed:

- All issues or repairs to electronic devices must be completed by or at the authority of technicians employed by the Tuscumbia City Schools System.
- Willful, deliberate, or habitual damages to the computers will cause Tuscumbia City Schools Board of Education to charge the student/parent the full cost of the replacement or repairs of the electronic device. Such cases may be turned over to the Tuscumbia Police Department.
- Each device will be equipped with tracking capabilities in the event a device is lost or stolen.
- All computers reported stolen must be reported, as soon as possible, to the local school administration. A police report is required within 48 hours, if not the student or parent/guardian may be held responsible for the cost of the replacement.
- All damage incidents will be investigated by the local schools administration.
- Technology Fee: Technology fees cover the cost of accidental insurance and monitoring software. Technology fees are broken down by grade bands and lunch status.

- Technology fee will not cover repairs from issues resulting from:
 - O Damage resulting in a broken screen caused by abuse or misuse. Actual costs of the repair will be charged at full cost of parts and labor.
 - Damage caused by abuse or misuse; to include, but not limited to, scratches, dents, and broken areas around ports, that does not otherwise affect functionality or impair your use.
 - O Damage as a result of a pet.
 - o Damage as a result of leaving the device in a hot car.
 - O Damage as a result of food, drink, or other liquid on or near the device.
 - o Damage as a result of negligence; to include, but not limited to, leaving the device or charger unattended, leaving the device or charger in an unsafe location or position, misuse, or improper handling.
 - o Damage caused by operating the product outside of the permitted or intended uses.
 - O Damage to a part, or product that has been modified to alter functionality or capability without the written permission of Tuscumbia City Schools.
 - o Any issue with the removal of, or damage to serial numbers, barcode, or identifying information.

I understand that I may refuse to pay the above fee schedule which covers all insurance related to the school issued device. If I opt out of the fees, I assume **all** responsibility to include theft, loss, accidental or intentional damages, or any other incurred cost to replace or repair the device.
